



India Tourist e-Visa

Visa Duration

One Month E-Tourist Visa (30 days)

This visa can be applied for online a minimum of 4 days in advance of the date of arrival. The cost of this e-visa is \$25 (and can be paid online). The validity would be 30 days from the date of your first arrival in India and double entry will be granted within the e-visa validity period stamped on your passport. Your first arrival must be between the date of issue and expiry as outlined on your granted ETA email.

One Year E-Tourist Visa

This visa can be applied for online a minimum of 4 days in advance of the date of arrival and can be applied for within 120 days in advance of the proposed date of travel. The cost of this e-visa is \$40 (and can be paid online). The validity would be 365 days from the date of the granted ETA as shown in your email. You will be allowed multiple entry into India with a maximum continuous stay of 90 days each visit.

Five Year E-Tourist Visa

This visa can be applied for online a minimum of 4 days in advance of the date of arrival and can be applied for within 120 days in advance of the proposed date of travel. The cost of this e-visa is \$484 (and can be paid online). The validity would be 5 years from the date of the granted ETA as shown in your email. You will be allowed multiple entry into India with a maximum continuous stay of 90 days each visit.

Completing The Form

- You will need to complete the application form on the official e-visa website <https://indianvisaonline.gov.in/evisa/tvoa.html>
- Before filling out the form, it may be helpful to familiarise yourself with the instructions and FAQs as outlined on the website (found on the lefthand side of the homepage).
- You will need to answer all of the necessary questions even if some of the questions do not seem particularly relevant. The whole process should take roughly 15-20 minutes to complete.
- Along with filling out the questions, you will also need to upload your photo and a photo of your passport. Please ensure your photo has a white background with no shadows, and shows your face/head from the shoulders up.
- Once you have applied online, it should take 48-72 hours to be processed and you will be notified by email with your visa status. **Please ensure to print out your granted ETA and carry it with you when you travel.** You can obtain a PDF copy of your visa approval from this page - <https://indianvisaonline.gov.in/evisa/StatusEnquiry>

Frequently Asked Questions

- **Your address in India**

Please put the name, address and telephone number of your first hotel in the trip. You will find the name of your hotels listed on the hotel page of your itinerary (you will be able to find all of the relevant addresses on Google or on their websites).

- **What is the address and number of the Tour Operator?**

- **Who are my UK and India references?**

For the India reference, please put the name, address and telephone number of your first hotel. For the UK reference, you can put down the details of a friend or family member.

- **I have been to India before, but cannot remember my previous visa number.**

If you have been to India before but do not know your previous visa number, you can input 00000 into the visa number box. It is however important to include the year you visited.

Important Notes

- UK passport holders need to ensure they always select their nationality as **'UNITED KINGDOM'**. The application does not recognise the other UK British options in the drop down menus.
- If you have an occupation that is part of the **Media, Journalist, Charity Sector, Social Worker, Police, Armed Forces, or are a Priest** - please call Siân as further documentation may be required.
- If you are self-employed or a freelancer, please ensure to put down the industry that you work in and your designation if possible. Failure to do so may flag the application and you will be required to send further information.
- If you have any Pakistan heritage within your family, please call Siân before completing your application.
- If using an iPhone/Mac or Safari internet browser, this may stop the application form from loading and saving correctly. It is best to use either Google Chrome or Firefox internet browsers to complete your application.

Uploading digital photograph and passport

- When uploading your documents, you will need to ensure they are in the correct formats.
- The digital photograph must be a JPEG, minimum 10KB - maximum 1MB.
- The photograph/scanned copy of your passport must be a PDF, minimum 10KB - Maximum 300KB.
- If you get stuck, please send your documents to Siân (sian@indiawoventravel.com) and she will amend the documents to ensure they are in the correct formats.
